## **Title Decal Placement**

It is important that you affix the decal in the proper location for the off-highway vehicle you own. Before affixing the decal to your vehicle, be sure the placement area is clean and dry.

If you affix the decal incorrectly, you may be cited by law enforcement.

 ATV - place the decal on the left rear quadrant on permanent plastic or metal frame as to be visible by outside inspection



2. OHM - place the decal on the left fork leg, either horizontal or vertical, visible from the left



 ROV - place the decal on the body of the vehicle on a flat surface on the driver side left rear of the vehicle so as to be visible by a person outside the vehicle



## New or Used ATV, Two-Rider ATV, or OHM Purchased <u>after</u> July 1, 2002 or an ROV Purchased after July 1, 2009

- 1. Proof of ownership; submit one of the following:
  - Manufacturer's Certificate of Origin with complete description of the OHV or ROV showing complete chain of ownership to the applicant(s)
  - Out of state title with complete description of the OHV or ROV in applicant's name or properly signed over to applicant(s) from owner of record
  - Florida certificate of title completed for transfer to new applicant(s)
  - Out of state registration and bill of sale from owner of record to new applicant(s), when out of state title is not required or dealer bill of sale to new applicant, when out of state title is not required.
  - Bill of sale from an individual or dealer who owned OHV <u>prior</u> to July 1, 2002, or ROV <u>prior</u> to July 1, 2009, and was not required to obtain or title in their name.
- 2. Florida application for certificate of title completed by applicant(s) form 82040
- 3. Lienholder information to include lien date or lien satisfaction when applicable
- 4. Weight slip when applicable
- 5. Florida sales tax or proof of payment
- Title fees

Required proof of ownership must show a complete description of OHV or ROV to include the year, make, vehicle identification number, and weight.

## When should an off-highway vehicle (OHV) be titled?

- Any off-highway vehicle purchased by a Florida resident after July 1, 2002
- Any off-highway vehicle purchased by a Florida resident, prior to July 1, 2002, that is operated on unrestricted public lands of this state

**Public Lands** are lands within the state that are available for public use and that are owned, operated or managed by a federal, state, county or municipal governmental entity.

## How do I obtain a Florida Certificate of Title for my OHV?

New or Used ATV, Two-Rider ATV, or OHM Purchased <u>before</u> July 1, 2002 or an ROV Purchased before July 1, 2009

- 1. Proof of ownership; submit one of the following:
  - Manufacturer's Certificate of Origin with complete description of the OHV or ROV showing complete chain of ownership to the applicant(s)
  - Bill of sale with complete description of the OHV or ROV
  - Notarized or perjury clause affidavit of ownership with complete description of the OHV or ROV
- Florida application for certificate of title completed by the applicant(s) - form 82040
- 3. Lienholder information to include lien date or lien satisfaction when applicable
- 4. Weight slip when applicable
- Title fees

Required proof of ownership must show a complete description of OHV or ROV to include the year, make, vehicle identification number, and weight.

(Other types of off-highway vehicles such as swamp buggies or dune buggies do not qualify under this requirement.)
